All products are warranted to be free from defective material and workmanship under normal use and service, as following terms, starting from the date of DBI's Invoice (proof of invoice required) : A. **3 months** for Battery. Enclosure breakage (not caused by dropping or abuse): B. **6 Months** for LED & Digital Display; C. **One (1) Year** for PC Boards; Power Supply (Transformer).

**Attention:** 1. Normal wear and tear is not covered under warranty after 2 weeks from shipping date. That includes Light Probe; Cosmetic Flaws; Enclosure Breakage, Dents, Scratches or Discoloration;

D.B.I. America's sole obligation under this Limited Warranty AT ITS SOLE DISCRETION is to repair or to replace the defective part or whole product, **provided the part or product is returned to its facility with client prepaid postage, delivery, or freight charges.** In the event warranty service must be performed to correct any defect, only DBI America shall provide this service upon mutually agreeable arrangements made in advance. DBI America and its distributors will not accept return of goods unless authorized in writing prior to the return of any shipment. The Shipment must be made in accordance with DBI's instructions. (See Below section "Return Merchandise").

**A. Ensure products have not been used. Merchandise must be returned with prepaid freight in the original packaging and in original (new) condition with all components included. Missing component will be charged in addition to Restocking Fee.**

**B. Returns must be made within 30 days of original purchase date.**

**C. Authorized returns will be subject to 20% Restocking Fee.**
